PRINCIPLES, EXPECTED EFFECTS AND NATIONAL IMPLEMENTATIONS FOR EU DIRECTIVES 31/2010 and 27/2012

The measures for the promotion and improvement of energy efficiency of buildings require the removal of obstacles in the energy market and to overcome the deficiencies that inhibit efficiency in the supply and end-use of energy.

The development of a strategy on the medium to long term is required to each EU member by the EU Directives mentioned in the title of this seminar that AiCARR offers in cooperation with REHVA.

In Italy, for example, the Legislative Decree 102/2014 imposes the energy retrofit of 3% of the whole surface of the buildings of the public administration early. The energy audit is becoming a key tool to address the retrofit with clear targets and transparent results.

Nowadays designer have to deliver at a European level: AiCARR, together with the European Federation of HVAC, would like to offer broader perspective and a moment of confrontation as well as an indication of the possible scenarios that will open shortly.
